(57) Abstract :

The present invention relates to an polyherbal composition for treating cancer, especially for lung useful for enhancing the quality of life. Further invention relates to the polyherbal comprising queous or organic solvent extract of Catharantus roseus, Sedum sarmentosum, Scutellaria barbata, Oldenandia diffusa, Rhizoma paridis, Scutellaria baicalensis, Ganoderma lucidum, Astragalus membranaceus, Codonopsis pilosula, and Bulbus fritillariae.
